- Copy of your professional license, i.e. physician, lawyer, nail technician, cosmetologist, etc.
- Copy of your occupational license (General contractor, homebuilder, HVAC, plumbing, etc.)
- Copy of your certificate of general liability and worker's compensation insurance
- To begin the process of selling alcoholic beverages, contact the ABC Board – (251) 947-2971. Once the application is complete, approval must be obtained from the City Council. A copy of the State Board alcohol license is required.
