**ORDINANCE 1016**  
**REPEALING ORDINANCE 398 LOCATIONS OF**  
**ALABAMA ALCOHOLIC BEVERAGE CONTROL BOARD STORES**

**WHEREAS**, the City of Bay Minette Ordinance 398 was adopted on June 15, 1937, by the Town Council of Bay Minette,

**WHEREAS**, Ordinance 398 regulates districts, within the City of Bay Minette, in which State liquor stores can be operated by the Alabama Alcoholic Beverage Control Board; and,

**WHEREAS**, the City of Bay Minette adopted Zoning Ordinance 959 on March 7, 2011 which established The Official Zoning District Map which delineates the boundaries of zoning districts: and,

**WHEREAS**, the Zoning Ordinance 959 has been amended by the following ordinances: Ordinance 969 adopted on August 3, 2015, Ordinance 977 adopted on August 21, 2017, Ordinance 992 adopted on April 6, 2020, Ordinances 993 and 994 adopted on October 5, 2020 and Ordinance 996 adopted on June 7, 2021.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA, IN REGULAR MEETING ASSEMBLED, AS FOLLOWS:**

**SECTION I: COUNCIL ACTION**

That Ordinance 398 regulating districts, within the City of Bay Minette, in which State liquor stores can be operated by the Alabama Alcoholic Beverage Control Board be repealed.

**SECTION II: SEVERABILITY.**

The provisions of this Ordinance are severable. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

**SECTION IV: EFFECTIVE DATE.**


This Ordinance shall be in full force and effect as of December 15, 2022

**SECTION V: POSTING OF ORDINANCE**


