



MUNICIPAL ELECTION POLL WORKER INTEREST INFORMATION

The City of Bay Minette will be holding its Municipal Election on August 26, 2025 and if necessary, a run-off election will be held on September 23, 2025. The City of Bay Minette has two (2) polling locations with Districts 1, 2, 3, and 5 voting at the John F. Rhodes Civic Center, 301 D'Olive Street, Bay Minette, Alabama; and District 4 voting at the Boykin Center, 900 Still Blvd, Bay Minette, Alabama. Polls are open from 7:00 a.m. until 7:00 p.m.

About Poll Workers

Poll workers are paid election officials who staff the local polling places to carry out assigned Election Day procedures. Their main duty is to ensure and protect the rights of every eligible voter in the City of Bay Minette. Their work begins before the election – as each worker is required to undergo training to carry out these tasks. Poll workers are required to arrive at respective places for which they have been appointed thirty (30) minutes before the poll opens and must stay until all closing duties are complete.

Poll Worker Qualifications

- **Must be a registered voter and reside within the city limits of the City of Bay Minette.**
- Each poll worker must attend a **mandatory poll worker training seminar**. The training class necessary for Poll Workers will be offered July 22, 2025, at 10 a.m. and at 6 p.m. at the Robertsdale Central Annex located at 22251 Palmer Street, Robertsdale, Alabama. **There are no exceptions to this requirement.**
- **Cannot** be a member of a candidate's immediate family or the second degree of kinship and cannot be part of candidate's political committee.
- Must be **available to work** on Election Day, August 26, 2025 and if necessary, on Run-off Election Day, September 23, 2025.
