

THE MINUTES OF THE REGULAR MEETING
OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA
AS HELD JUNE 16, 2014

The regular called meeting of the City Council of the City of Bay Minette was held June 16, 2014 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Wills, Councilmember Danleigh Corbett, Councilmember Kathy Dobbins, Councilmember John Biggs, Councilmember Dollie Mims, and Councilmember Chris Norman. Others in attendance were: Rita Findley, City Clerk; Joe Landenwich, Finance Director; Clarence Crook, Police Chief; Mike Minchew, Fire Chief; and Trey Dickson, Court Magistrate.

Mayor Wills called the meeting to order and Chief Crook gave the invocation. Councilmember Mims led the pledge of allegiance.

Mayor Wills asked for a motion to approve the Consent Agenda which included the following items: **Item A:** Approve Minutes of June 2, 2014 City Council Meeting and Work Session. **Item B:** Consideration of Training Request for Kim Curry, Accounts Payable Clerk to attend "Organizing and Managing Accounts Payable" in Mobile, Alabama at a cost of \$245.21 **Item C:** Monthly Reports. Councilmember Dobbins moved to approve the consent agenda. The motion was seconded by Councilmember Corbett and unanimously carried.

The Report of Finance Committees and Board/Commissions included the following:

Mayor Wills asked for a motion to approve the payables in the amount of \$132,495.17. Councilmember Corbett moved to approve the payables. The motion was seconded by Councilmember Mims and unanimously carried.

The Mayor's Report:

Mayor Wills presented an update on Ride Yellow and Unity Day which was held Saturday, June 14, 2014.

Mayor Wills expressed his condolences to the family of former City Councilmember Melvin Bradley.

Mayor Wills asked for a motion to table Item 6: Consideration of Adoption of Sign Ordinance on second reading. Councilmember Mims moved to approve the request. The motion was seconded by Councilmember Norman and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0614-01 on second reading to award the Bid for Seasonal Decoration. The motion was made by Councilmember Biggs. The motion was seconded by Councilmember Corbett and carried unanimously.


