

THE MINUTES OF THE REGULAR MEETING  
OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA  
AS HELD APRIL 20, 2015

The regular called meeting of the City Council of the City of Bay Minette was held April 20, 2015 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Wills, Councilmember Danleigh Corbett, Councilmember Kathy Dobbins and Councilmember John Biggs. Councilmember Dollie Mims and Councilmember Chris Norman were absent. Others in attendance were: Scotty Lewis, City Attorney; Rita Findley, City Clerk; Joe Landenwich, Finance Director; Tina Covington, Public Relations Coordinator; Mike Minchew, Fire Chief; John Bower, Grounds/Parks Superintendent and Trey Dickson, Court Magistrate.

Mayor Wills called the meeting to order and Cliff McCollum gave the invocation. Councilmember Corbett led the pledge of allegiance.
