## THE MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD JANUARY 18, 2018

The regular called meeting of the City Council of the City of Bay Minette was held January 18, 2018 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, rescheduled date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Mayor Wills called the meeting to order and gave the invocation. Councilmember Biggs led the Pledge of Allegiance.
