

**THE MINUTES OF THE REGULAR MEETING  
OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA  
AS HELD JUNE 4, 2018**

The regular called meeting of the City Council of the City of Bay Minette was June 4, 2018 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Wills; Councilmember Danleigh Corbett; Councilmember Mike Phillips; Councilmember John Biggs; and Councilmember Shannon Clemmons; Councilmember Taylor was absent. Others in regular attendance: Scotty Lewis, City Attorney; Rita Diedtrich, City Clerk; Tammy Smith, Administrator/Finance Director; Tina Covington, Public Relations Coordinator; Al Tolbert, Police Chief; Mike Minchew, Fire Chief; Ashley Jones, North Baldwin Chamber of Commerce; and Tripp Ward, Alabama Power Company. Guest included: Jill Everson and Ben Hansert, North Baldwin Infirmary Health.

Mayor Wills called the meeting to order and gave the invocation. Councilmember Clemmons led the Pledge of Allegiance.

Mayor Wills read a Proclamation for RideYellow and asked for a motion to approve the proclamation. Councilmember Biggs moved to approve the proclamation. The motion was seconded by Councilmember Clemmons and unanimously carried. Mayor Wills presented the proclamation to Ben Hansert and Jill Everson from North Baldwin Infirmary Health.

Mayor Wills asked for a motion to approve the consent agenda. Item A: Approve Minutes of May 24, 2018 City Council Meeting and WorkSession. Councilmember Biggs moved to approve the Consent Agenda. The motion was seconded by Councilmember Clemmons and unanimously carried.

There was not a Mayor's Report.


