THE MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD JUNE 17, 2019

The regular called meeting of the City Council of the City of Bay Minette was held on June 17, 2019 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Mayor Wills called the meeting to order and gave the invocation. Councilmember Biggs led the Pledge of Allegiance.

Mayor's Report

Councilmember Biggs moved to approve the request. The motion was seconded by Councilmember Clemmons and unanimously carried.

Mayor Wills asked for a motion to approve the bid from American Tennis to repair the tennis courts with the cost to be split with Coastal Community College and Baldwin County High School/Baldwin County Board of Education and the City of Bay Minette. Councilmember Clemmons moved to approve the project. The motion was seconded by Councilmember Phillips and unanimously carried.

Councilmember Corbett moved to approve the resolution. The motion was seconded by Councilmember Taylor and unanimously carried.
