## THE MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD SEPTEMBER 16, 2019

The regular called meeting of the City Council of the City of Bay Minette was held on September 16, 2019 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of Council were found to be present: Mayor Robert A. Wills; Councilmember Mike Phillips, Councilmember John Biggs; Councilmember William Taylor and Councilmember Shannon Clemmons; Absent: Council Danleigh Corbett due to his death on Saturday, September 14, 2019. Others in regular attendance Scotty Lewis, Attorney; Tammy Smith, City Administrator/Finance Director; Rita Diedtrich, City Clerk; Tina Covington, Community Relations Coordinator; and Police Department: Al Tolbert, Rufus Thompson, Jonathan Hall and Jeff Weaver; North Baldwin Chamber Junior Ambassadors: Loriann McCullough, Olivia Lamb and Alison Wilson; Martha Ryan, The First Bank; Tripp Ward, Alabama Power Company; A. C. Ulmer and Harry Still, III.

Mayor Wills called the meeting to order and gave the invocation. Councilmember Biggs led the Pledge of Allegiance.

## Consent Agenda

Mayor Wills asked for a motion to approve the consent agenda. Councilmember Taylor moved to approve the consent agenda. The motion was seconded by Councilmember Clemmons and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0919-01 To Adopt the FY2019-2020 City Budget on second reading. Councilmember Phillips moved to approve the resolution. The motion was seconded by Councilmember Clemmons and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0919-04 Reserving the Unencumbered Funds in the FY 2018/19 General Fund Operating Budget and Capital Projects Budget for Application in the FY 2019/20. Councilmember Biggs moved to approve the resolution. The motion was seconded by Councilmember Taylor and unanimously carried.
