The regular called meeting of the City Council of the City of Bay Minette was held on January 21, 2020 at 6:00 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

Mayor Wills called the meeting to order and Councilmember Taylor gave the invocation. Councilmember Phillips led the Pledge of Allegiance. Mayor Wills extended condolences to Councilmember Clemmons on the death of his father-in-law.
