

**THE MINUTES OF THE REGULAR CALLED MEETING  
OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA  
AS HELD MARCH 1, 2021**

The regular meeting of the City Council of the City of Bay Minette was held on March 1, 2021 at 6 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of the Council were found to be present: Mayor Robert A. Wills; Councilmember Pete Sellers; Councilmember Mike Phillips; Councilmember Matt Franklin; Councilmember William Taylor; and Councilmember Shannon Clemmons. Others in regular attendance: Scotty Lewis, Stone-Crosby, PC; Tammy Smith, City Administrator/Finance Director; Rita Diedtrich, City Clerk; Al Tolbert, Police Chief; Joseph Hall, Superintendent of Parks/Grounds/Custodial and Recreation; and Ashley Jones-Davis, North Baldwin Chamber of Commerce. Guests included: Norman Cale, A.C. Ulmer, and Rick Lender.

Mayor Wills called the meeting to order and gave the invocation. Councilmember Taylor led the Pledge of Allegiance.

*Consent Agenda*

Mayor Wills asked for a motion to approve the consent agenda. Item A: Approve Minutes of February 17, 2021 City Council Meeting and Work Session; Item B: Consideration of Training Request for Heather Ford, Court Magistrate to attend the Regional Meeting in Mobile, Alabama on May 6, 2021 at a cost of \$236.55. Councilmember Sellers moved to approve the consent agenda. The motion was seconded by Councilmember Franklin and unanimously carried.

Mayor Wills asked for a motion to approve the payables in the amount of \$257,619.01. Councilmember Phillips moved to approve the payables. The motion was seconded by Councilmember Taylor and unanimously carried.

*There was not a Mayor's Report.*


