THE MINUTES OF THE REGULAR CALLED MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD APRIL 1, 2021

The regular meeting of the City Council of the City of Bay Minette was held on April 1, 2021 at 6 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of the Council were found to be present: Mayor Robert A. Wills; Councilmember Pete Sellers; Councilmember Mike Phillips; Councilmember Matt Franklin; Councilmember William Taylor; and Councilmember Shannon Clemmons. Mayor Wills called the meeting to order and gave the invocation. Councilmember Clemmons led the Pledge of Allegiance.

Consent Agenda

Mayor Wills asked for a motion to approve Resolution Number 0421-05 Rescinding Resolution Number 00321-02 CB2021-01—Cemetery Landscape Maintenance. Councilmember Phillips moved to approve the resolution. The motion was seconded by Councilmember Sellers and carried with the ayes being: Mayor Wills, Councilmember Sellers, Councilmember Phillips, Councilmember Franklin and Councilmember Clemmons; Councilmember Taylor abstained.

Mayor Wills asked for a motion to approve Resolution Number 0421-06 Awarding CB2021-01—Cemetery Landscape Maintenance to Adult and Teen Challenge Alabama. Councilmember Franklin moved to approve the resolution. The motion was seconded by Councilmember Phillips and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 0421-07 Authorizing and Directing Mayor to take necessary actions to facilitate the processing of the City's FEMA claim (DR4563AL) for damages as a direct result of Hurricane Sally. Councilmember Sellers moved to approve the resolution. The motion was seconded by Councilmember Taylor and unanimously carried.
