## THE MINUTES OF THE REGULAR CALLED MEETING OF THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA AS HELD OCTOBER 4, 2021

The regular meeting of the City Council of the City of Bay Minette was held on October 4, 2021 at 6 p.m. at the City Hall in Bay Minette, Alabama; this being the proper place, scheduled date and hour for holding such meeting.

On roll call, the following members of the Council were found to be present: Mayor Robert A. Wills; Councilmember Matt Franklin; Councilmember William Taylor and Councilmember Shannon Clemmons; Councilmember Pete Sellers and Councilmember Mike Phillips was absent. Mayor Wills called the meeting to order, and Councilmember Taylor gave the invocation. Councilmember Clemmons led the Pledge of Allegiance.

Consent Agenda

Mayor Wills asked for a motion to approve the consent agenda. Item A: Approve Minutes of the September 20, 2021 City Council Meeting and Work Session. Councilmember Clemmons moved to approve the consent agenda. The motion was seconded by Councilmember Taylor and unanimously carried.

The Report of Finance Committees and Board/Commissions included the following:

Mayor Wills asked for a motion to approve Resolution Number 1021-04 Ratifying and Confirming the Sale of Surplus NBU Property. Councilmember Clemmons moved to approve the Resolution. The motion was seconded by Councilmember Franklin and unanimously carried.

Mayor Wills asked for a motion to approve Resolution Number 1021-05 Confirming the City Depositories. Councilmember Franklin moved to approve the Resolution. The motion was seconded by Councilmember Taylor and unanimously carried.

Mayor Wills asked for a motion to approve the request from the Baldwin County Sheriff's Office to close 4<sup>th</sup> Street as reviewed by the Baldwin County Sheriff's Office and the City of Bay Minette Planning and Development Department with the closure to begin on October 11, 2021; the County providing barricades with flashing lights and that any damages to City property would be repaired. Councilmember Franklin moved to approve the motion. The motion was seconded by Councilmember Clemmons and unanimously carried.

Barbara Brown presented an update on the Douglasville School of Arts and Recreation.
