ORDINANCE NO. 1028

REPEALING ORDINANCE 377 AND ORDINANCE 447 CITY DEPOSITORIES

WHEREAS, City of Bay Minette Ordinance 377 was adopted on November 21, 1933, and Ordinance 447 was adopted on March 17, 1942, by the Town Council of Bay Minette; and

WHEREAS, Ordinance 377 and Ordinance 447 require that all deposits be deposited into the Baldwin County Bank, Bay Minette, Alabama and Merchants National Bank, Mobile, Alabama;

WHEREAS, Baldwin County Bank and Merchants National Bank are no longer in business; and

WHEREAS, the City of Bay Minette adopted Resolution 1022-01 Confirming the City Depositories on October 3, 2022.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA, IN REGULAR MEETING ASSEMBLED, AS FOLLOWS:

SECTION I: COUNCIL ACTION

That Ordinance 377 and Ordinance 447 City Depositories are hereby repealed.

SECTION II: SEVERABILITY.

The provisions of this Ordinance are severable. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

SECTION III: EFFECTIVE DATE.


This Ordinance shall be in full force and effect as of upon its adoption by the City Council of the City of Bay Minette and publication as required by law.

SECTION IV: POSTING OF ORDINANCE

Ordinance 1028 shall be posted in three public locations as required by law. Posting locations include Bay Minette City Hall; Bay Minette Public Library and North Baldwin Utilities.

FURTHER, BE IT RESOLVED AND ORDAINED, BY THE CITY COUNCIL OF BAY MINETTE, ALABAMA IN REGULAR MEETING ASSEMBLED, determined that Ordinance 1028 repealing Ordinance 377 and Ordinance 447, is hereby **ADOPTED**.
