ORDINANCE NO. 1012
AMENDING ORDINANCE 976 GENERAL LICENSES
TO REFLECT THE FIVE-YEAR ADJUSTMENT TO
MUNICIPAL BUSINESS LICENSE ISSUANCE FEES

WHEREAS, Alabama Department of Revenue (ALDOR) is required by law to analyze the U.S. Department of Labor's Producer Price Index and determine how much municipal business license issuance fees should increase every five license years; and,

WHEREAS, every five years, the Alabama Department of Revenue (ALDOR) is responsible for establishing and publishing adjustments to municipal business license issuance fees, as well as notifying all municipalities and the Alabama League of Municipalities of any such fee increase no later than November 30 preceding the affected license year. (Section 11-51-90, Code of Alabama 1975, and Departmental Rule 810-8-5-.15); and,

WHEREAS, based on the U.S. Department of Labor's Producer Price Index, Alabama Department of Revenue (ALDOR) states that municipal business license issuance fees remain or may be adjusted to a maximum amount of \$14, at the discretion of each municipality, for the license year beginning January 1, 2023.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BAY MINETTE, ALABAMA, IN REGULAR MEETING ASSEMBLED, AS FOLLOWS:

SECTION I: Business License Fee.

That Ordinance 976 be amended by Ordinance 1012 to increase the municipal business license issuance fee from \$12 to \$14 for each license year.

SECTION II: REPEALER.

Any ordinance or resolution heretofore adopted by the Council which is in conflict with this Ordinance is hereby repealed to the extent of such conflict.

SECTION III: SEVERABILITY.

The provisions of this Ordinance are severable. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

SECTION IV: EFFECTIVE DATE.


This Ordinance shall be in full force and effect as of January 1, 2023.

SECTION V: POSTING OF ORDINANCE


