Notice is hereby given that the City of Bay Minette Planning Commission and City Council will each conduct a public hearing for the Baldwin Ventures, LLC property for Case No. Z-24001, zoning amendment request for a Planned Unit Development (PUD). The Planning Commission will also review a concurrent request for Case SD-24001, Master Plan approval for the Old Towne Commons PUD development. Both cases will be reviewed at the time and locations listed below.

The subject properties, specifically identified as Parcel I.D. 05-28-05-21-0-000-009.001 // PIN 92518, 05-28-05-21-0-000-002.001 // PIN 222473, 05-28-05-21-0-000-002.000 // PIN 31532, 05-28-05-21-0-000-009.000 // PIN 83618, 05-28-05-21-0-000-001.000 // PIN 62828 totals 413.4± acres is located along State Hwy 59. The five (5) parcels, as specified above, are requesting to be rezoned from the R-3, Higher Density Single Family (316.8± acres); R-4, High Density Multi-Family (50.2± acres) and B-2, General Business District (47± acres) for a Planned Unit Development (PUD). The proposal includes 827 single family residential units, 392 multi-family units and 47± acres of commercial development. The proposed Master Plan can be viewed on the Planning Department website, in-office or by email request. A map of the subject properties can be found on the back of this notice.

The <u>second reading</u> of the rezoning ordinance is scheduled during its regularly scheduled meeting on <u>Monday, March 18, 2024</u> beginning at 6:00 p.m., also in the Council Chambers of Bay Minette City Hall.
