Access/Culvert permits are intended to promote the overall safety of motorists, bicyclists, and pedestrians; to reduce interference with through traffic by other vehicles entering, leaving, and crossing streets; to assure safe access to and from streets by emergency vehicles; and to preserve the traffic capacity of streets. No curbs or rights-of-way may be cut, paved, or otherwise altered until a permit for the access/driveway has been secured from the City and/or any other governmental agency owning or controlling the street right-of-way. An access/driveway, which demonstrates a potential danger to the public and/or which could affect the safe, efficient flow of traffic, may be denied following a recommendation from City Staff, based on commonly accepted and applied traffic engineering principles, emergency response requirements or other potential threats to the health, safety and welfare of the public.
